General Membership Meeting January 8th, 2013 at Brewstone Beer Company, 3466 Wm Penn Highway, Monroeville

Regional Executive Mark Connolly called the meeting to order at 7:30 PM.

A motion (Merritt/Kaplan) to approve the minutes of the January meeting as published passed 11-0-0. We have two guests tonight, Tim & Bryan Wadsworth, owners of Track First in Hudson OH.

TREASURER'S REPORT: AJ Anselm

We have a checking balance of \$48,064.17. A copy of the full report is in the archives with the original minutes.

SOLO REPORT: Frank Gaus

We have the signed contracts with PIRC in hand. We are working on the financial projections.

We have made arrangements to have an Autocross car at the new car auto show. Glen Hoffman is doing trifold fliers for distribution at the show.

TRACK TRIALS REPORT & HILLCLIMB REPORT: Dave Merritt

A copy of the financial projections was distributed. A copy is in the archives with the original minutes.

SCCA National is raising sanction fees from \$100 to \$200. We will only raise entry fees by \$5.

Issues we had with the Track Trials rules have been resolved.

MEMBERSHIP: Paula Hawthorne

At the end of January we showed 382. In 2013 this number was 358 members, and in 2012 it was 379, so we have had limited (about 8%) membership growth. We show 83% retention, which is above the regional average of 76%. Comparing us to the three leading Medium Regions, our growth is lower, but our retention is much higher.
