Registration is open for the June event. Alliance is donating some Brake pads, and an anonymous individual has donated cash for a tow fund to be split \$150/\$100/\$50 for 1st through 3rd.

VRG was amazed that we had seven students because that is more than they usually get. We received their compliments.

The observers report was good except for sound control equipment. We still need to fix that situation.

OLD BUSINESS:

Nearly 5 pounds of sterling silver, it has been appraised at nearly \$4000. He would like to have it restored, along with the Dasey & Bauchmyer awards. We have dealt with S&S Trophy for years, and Mark C. will get us an estimate.

Paula told us that the former meeting place Gene's Last Chance has been reopened as Street King's Bar & Grille. We will consider this a possible meeting place. Our next meeting is in Monroeville.

Paula passed out some job descriptions for club officers that she got from someone from Hawaii Region. She would like feedback from the officers who received them as to whether they adequately describe the position. Walt pointed out that our current bylaws have these positions described.

Barry mentioned that Nelson Ledges opened last weekend for the bikes. Reports are that the surface is falling apart, the water pump is broken, and Dave & Tony's food is gone. Be prepared.

We need to try to get our volunteer workers to use Motorsportsreg.org to preregister for our events. This gives us a count for meals and such.
