The Solo Nationals are running now, and about 30 STC members are there. At least one STC driver has won a class every year since 2018. There are 1290 people at the Solo Nationals this year

ROAD RACING REPORT: Bob Albert

The National Track Trials championship races will be held at PittRace on the third weekend of September, 2025. We can hold our own events some other time and keep the money.

Our events in 2025 will be dual events with Great Lakes. Winning points will apply to either Division. This should draw entries from Great Lakes Division.

Paula discussed hearing road racing drivers being compared to track trials drivers and what they paid. Trials drivers get more minutes per dollar. Road Racing uses 35 cars per mile X 2.78, while Track Trials does 25 cars per session. RR charges \$575 per weekend, TT charges \$475, and that causes speculation. We are already working on a schedule for the 2025 Majors.
