We discussed a merger with NeOH Region for a race at our track. This should be in New Business.

#### **OLD BUSINESS:**

We will ask PittRace about trailer storage fee discounts at our next meeting with them.

Bill Haus went to Watkins Glen to learn how to do Sound Control, and plans to do that for us next season.

#### **NEW BUSINESS:**

This came up under Road Racing - we plan to try to merge with NeOH Region to race at PittRace There are issues at Nelson Ledges, and there is a staffing shortage. There are a lot of details to work out. We need a written contract agreement with NeOH. To have a combined Majors might be an issue with the Division sanction, and we might need a clearance from National. Bob is already working on these things.

# A motion (Gene Kern/Joe Montuoro) to table discussion until the Regional Executive and Road Racing Chairperson get more detail on the future passed 10-0-0.

Amanda Haines now has a National license for Registration.

For 2026, the cost of wreckers and personnel (Ian/Lucky Towing & Recovery) will be included in our track fees, and will increase our costs around \$300 per event.

Gene Kern asked that our Board of Directors nominating petition be available prior to the Festival so that they could be circulated there, since meetings are so poorly attended. Walt said it would be ready and posted to the website and sent to the current Board members.

Dan Dennehy stated that he would be retiring as Competition Chair at the end of this year. We should get a successor involved in September. Gene Kern kind of volunteered.

Jeff requested BOD approval of a loan of our timing gear to National for the Runoffs. Discussion followed. A motion (Gene Kern/Don Baker) to loan our timing equipment for the Runoffs passed 9-1-0 (Dennehy). Jeff should try to turn the requested loan into a rental. Since we have been fined for completing our Supps for the Festival late, perhaps we can negotiate something. A motion (Dennehy/Granche) to ask for a waiver of our fine in exchange for the loan of our equipment passed 10-0-0. Jeff agreed to ask for a waiver of the fine.

A motion (Matenkosky/Montuoro) to adjourn passed 10-0-0 at 8:07 PM.
